



## HREC Capital Markets Group Arranges \$30.9 million Refinancing of Eight Midwest Hotels

The portfolio refinancing includes the Stoney Creek Hotels in Columbia, MO, Johnston, IA, Galena, IL, Quincy, IL, St. Joseph MO, Moline, IL, Peoria, IL, and Sioux City, IA. The non-recourse loan was provided by BMO Capital Markets, served to pay off various maturing debts, and features a 10-year term, a fixed rate of 6.44%, a three-year interest only period and thirty-year amortization thereafter.

The negotiations were led by Greg Porter, Managing Director – Capital Markets, in HREC’s San Diego office. “We are pleased to have sourced an elegant financing solution for the Stoney Creek Hospitality team in the midst of a challenging debt market for independent-branded hotels.
